# What is an Angel Investor?

## What is an Angel Investor?

An angel investor is an individual who invests their own money in early-stage startups in exchange for equity or convertible debt. They typically provide financial support during the initial phases of a company's development, when risks are high and traditional financing options are limited.

#### Beyond Capital

Angel Investors often contribute more than just capital; they may offer **guidance**, **mentorship**, and valuable business **connections** to help the startup thrive.

# What Sets Angel Investing Apart from Venture Capital?

Angel investing is similar in many ways to venture capital, however there are differences.

Angel investors are typically individuals investing their own **personal funds**, compared to venture capitalists (VCs) who are part of professional firms and invest pools of capital raised among limited partners.

While the lines are often not clearly defined, angel investors usually **invest earlier** than VCs, sometimes when the founder only has an idea or prototype.

Angel investors typically write **smaller cheque** amounts than VCs, in the range of \$10,000 to \$100,000, perhaps even less.

As individuals are investing their own money, angel investors can often **decide more quickly** whether to invest.

#### Angel Investors Play a Critical Role in the Startup Ecosystem

By offering vital capital and support, angel investors enable groundbreaking innovation and the creation of new businesses. They're key to helping startups progress from a raw idea to securing subsequent funding.

### The Main Characteristics of Angel Investors

#### **PERSONAL FUNDS**

They invest their own capital instead of managing pooled funds as venture capitalists do. Make sure you consult your tax and investment advisors when investing in this asset class.

#### **EARLY-STAGE INVESTMENT**

They concentrate on startups in the early growth phases prior to generating substantial revenue. Learn about the different funding stages, from pre-seed to seed to series A funding.

#### **EQUITY OR CONVERTIBLE DEBT**

In exchange for their investment, angel investors typically receive ownership equity (shares or ownership stake) or a convertible note that can later be converted into shares, as specified in the convertible debenture agreement. Learn more about equity, venture debt, and convertible notes.

#### **MENTORING ROLE**

Angel investors often offer expertise, experience, and networks to help support the startup's growth.

#### **DIVERSE BACKGROUNDS**

Angel investors can be former entrepreneurs, professionals, or affluent individuals interested in fostering innovation.

#### **HIGH RISK, HIGH REWARD**

Investments carry risks since many startups fail; however, successful ventures can yield substantial returns.
